PROCUREMENT NOTICE Renting of Office Space

IFB No. MWFC/F/04/25/I

- 1. The Ministry of Wildlife & Forest Resources Conservation intends to rent an office space of an area around 15,000ft², with parking facility of 30 number of motor cars or vans and with or without partitioning in accordance with the requirement of the Ministry for office purposes at **Sri Jayawardenpura Kotte, Battaramulla, Borella Narahenpita or surrounding areas** for a duration of three (3) years. Duration will be extended thereafter if necessary.
- 2. The proposed building should be of reinforced concrete, within a radius of 200 meters from the nearest bus stop or bus station, with easy access for vehicles and provided with essential amenities such as toilet facilities (male & female separately), water, adequate lighting, parking facilities etc., to serve as offices, conference rooms, etc.
- 3. Bidding document together with the finalized detailed requirements may be collected from the accounts branch upon a payment of non-refundable fee of Rs. 3000/= to the Accounts section of Ministry of Wildlife & Forest Resources Conservation from 13.11.2023 at the address given below (on working hours).
- 4. A bid security worth of Rs. 30,000/= and valid until 06.03.2024 should be submitted with the bid.
- 5. The duly completed Bidding Document accompanied by valid bid security should be sealed in a single envelope, clearly marked with the Procurement Reference Number and the procurement name at the left hand corner of the envelope and addressed to the Secretary, Ministry of Wildlife & Forest Resources Conservation, 1090, Sri Jayawardanepura Mawatha, Rajagiriya. The sealed envelopes should be deposited in the Tender Box located at the said office not later than 10.00 am local time on or before the 22.11.2023.
- 6. Sealed bidding documents by hand or by post should reach the same address by the same date and time at latest and bids will be opened in the presence of the bidders or their representatives who choose to attend in person immediately after the bid closing. Late submissions will be rejected and shall be returned unopened to the bidder concerned.
- 7. The Ministry of Wildlife & Forest Resources Conservation requires that the Office Space with necessary facilities and with or without partitioning be made available as from 15.12.2023. Priority will be given to the bids with partitioning.
- 8. The Ministry of Wildlife & Forest Resources Conservation reserves the right to
 - (a) accept or reject any bid; and
 - (b) annul the bidding process and reject all bids at any time prior to contract award, without incurring any liability towards the bidder.
